As a Title IV institution UWest must produce and distribute an annual report containing crime statistics and statements of security policies, pursuant to 20 United States Code Section 1092(f), the Jeanne Clery Disclosure of Camps Security Policy and Campus Crime Statistics Act. ### **CAMPUS CRIME STATISTICS**

This report contains categories of crime statistics for the campus and certain non-campus properties which have been reported to local police and campus security authorities for the most recent three calendar years. It is combined statistics from UWest’s General Services Department, Student Services Department and the Los Angeles Police Department and includes on-campus, non-campus, and public property adjacent to the university’s facilities.
